Prof. Sasmita Samanta, Vice Chancellor & Chairperson of the Board of Management welcomed all the esteemed members and present in the 43rd Board of Management Meeting. She informed the board that the University celebrated KIIT Silver Jubilee, marking 25 years of institutional and academic excellence.

She spoke about the tremendous growth and milestones the university has achieved over the past 25 years. She also mentioned that the university has a 100% growth rate across all sectors, including academics, entrepreneurship, infrastructure, and research, and that it will continue to do so in the upcoming year. She also said the responsibility of the board is increasing day by day as public expectations of the institution increase.

The chairperson was happy to inform that the university is getting good visibility in researchoriented science and technological platforms, and our faculties are getting inducted into the technological and science boards of government as members and evaluators.

The University has been ranked in the Times Higher Education (THE) World University Rankings 2023: 601-800 rank, the Engineering and Technology Rankings 2023: 401-600 rank, the Computer Science Rankings 2023: 301-400 rank, and the Clinical & Health Rankings 2023: 201-250 rank.

Then Prof. J. R. Mohanty, Registrar of KIIT-DU, thanked the Chairperson, Board of Management, and welcomed all the members. After that, he started the discussion as per the agenda items.

- (1) The research scholar must have at least two indexed (Scopus/SCI/WOS/SSCI/Pubmed) papers either published or accepted for publication with him/her as the first author
- (2) The research scholar must have one paper where he/she is the first author and at least another paper where he/she is the corresponding author.
- (3) The research scholar must have one paper where he/she is the first author and at least one patent which is granted.

The above mentioned recommendations by the ACM are placed before the Board for approval.





Distribution of Subjects of papers published in 2022 1802 Document results






International collaboration with 53 countries in 2023 till 4th March




