At the outset, the Director welcomed all the members present and briefed them about the agenda.
The following items were discussed and resolved :

Item No. 01 : Confirmation of the Minutes of the previous meeting held on 24/04/2015 and an emergency meeting held on 20/02/2016

Resolved that the Minutes of the previous meeting held on 24/04/2015 and 20/02/2016, be treated as read and approved.

Item No. 02 : To discuss on Ph.D. Course Work Syllabus of School of Law

The Director placed office notes, including two lists of subjects regarding Ph.D. Course Work of 2014 and 2015 admitted batch Scholars, as approved by the Vice Chancellor on 02/05/2016.

Resolved that all the Ph.D. Scholars of School of Law should undergo the following courses:

1. Research Methodology - Common for all
2. Any one paper from List I, which consists of 10 Core Subjects of Law
3. Another paper to be taken from List II, which consists of 10 specialized papers of Law

The detail syllabus of Ph.D. Course Work including Research Methodology and list of 10 core and 10 specialized subjects have been approved and recommended to the Academic Council for consideration and approval.

It is further resolved that from next academic year, i.e. 2016 admitted batch, the course work on Research Methodology of the Ph.D. Scholars will be conducted by School of Law itself along with 2 other papers.

Moreover, the specialized papers in List II are not exhaustive and therefore recommended for revision in every 3 years.

Item No. 03 : To review on the duration of End Semester Examination time

The members reviewed the duration of End semester Examination time and reiterated their earlier decision taken on 13/06/2014 that the duration of time for End Sem. Examination will be of 2.30 hrs. instead of 3 hrs.

Resolved that the views be sent again to the Academic Council for consideration and necessary decision in this regard.

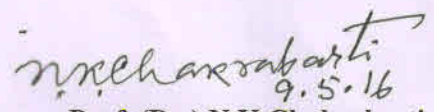
Item No. 04 : Miscellaneous

(j) Introduction of Animal Law in undergraduate LL.B. Courses as optional paper.

In view of the circular issued by the Bar Council of India, on principle, we agreed in our emergency meeting to introduce Animal Law as an optional paper in undergraduate Law Courses. The draft syllabus has been placed for consideration of the members and the note from the Vice Chancellor is also placed for consideration.

Resolved that paper on Animal Law with the detail syllabus as modified in this meeting be introduced from next academic session in 10th Semester as Optional / Seminar Paper .
